### SPECIAL CALL TO ACTION...LEGAL BATTLE AHEAD!

The Southern Poverty Law Center (SPLC), the activists behind the "hate" list, lumps Christian lobby groups like the Family Research Council (FRC) and the legal giant Alliance Defending Freedom (ADF), which has argued and won numerous cases in the U.S. Supreme Court, in with the Ku Klux Klan and neo-Nazis.

Its infamous "hate list" directed Floyd Lee Corkins to FRC's Washington office, where he shot a security guard and planned to massacre the group's staff. He told police he targeted FRC because the SPLC labeled them "anti-gay."



While the rest of the country looked on with horror at the events unfolding in Charlottesville, there was one group who managed to turn quite a profit from the tragedies of that August day: Southern Poverty Law Center (SPLC). Still reeling from their latest public relations crisis when a second gunman, congressional baseball shooter James T. Hodgkinson, was identified by investigators as a fan of Morris Dees's group.

Desperate for a way back into the media's good graces after five years of trying to explain away the FRC shooting that its "hate map" inspired, the tensions in Virginia were exactly the opening Dees was looking for. Pouncing on the opportunity to regain credibility, SPLC, who'd been skating by on a civil rights reputation that expired decades ago, fired up the old propaganda machine -- earning millions of dollars in the process. Apple's Tim Cook, celebrity George Clooney, and J.P. Morgan pumped millions into the group after Charlottesville, putting a temporary hold on the media's questions about the group's shady dealings and controversial methods.

For Dees and lieutenant Richard Cohen, it was a welcome reprieve from the skepticism that was starting to take hold in the mainstream press, where outlets like Politico and the Wall Street Journal were beginning to expose the organization's dangerous mission. The dominos that started to fall when the FBI, U.S. Army, and Obama Justice Department distanced themselves from SPLC was beginning to threaten the viability to the Left's favorite arbiters of "hate." After years as the media's darling, Dees's group was suddenly staring down headlines like *"The Insidious Influence of the SPLC"* and damaging reports about its suspicious offshore accounts and partnerships.

Charlottesville put a stop to all of that, thanks to media liberals who are all-too-willing to help SPLC grind its political ax. Several media organizations used the opportunity to expand the platform of the liberal activist group helping to resurrect SPLC's sham of neutrality.

That has to stop, FRC and 46 other organizations declared today in an open letter to the press. The events of Charlottesville don't negate -- or in any way excuse -- **SPLC's track record of inciting the very violence it condemns.** *"The SPLC is a discredited, left-wing, political activist organization that seeks to silence its opponents with a 'hate group' label of its own invention and application that is not only false and defamatory, but that also endangers the lives of those targeted with it,"* dozens of conservative leaders explain.



*"We are writing to you as individuals or as representatives of organizations who are deeply troubled by several recent examples of the media's use of data from the Southern Poverty Law Center (SPLC)" -- which, by its own admission, is completely fabricated and devoid of any methodological standard. "Our criteria for a 'hate group,' first of all, have nothing to do with criminality or violence..." SPLC's Mark Potok confessed. "It's strictly ideological." Hence, why the group lumps true extremists -- like the Ku Klux Klan -- in with mainstream conservatives whose only fault is not sharing SPLC's radical ideology. "We're not trying to change anyone's minds," SPLC's Potok said plainly. "We're trying to wreck the groups. We're trying to destroy them." Does that sound like the gospel of peace and tolerance?*

# WATCH: Women's March Organizer Linda Sarsour Calls For 'Jihad' Against Trump

Speaking at the Islamic Society of North American Convention last weekend, Women's March organizer Linda Sarsour ripped into the Trump administration and called for "jihad" against Trump. ISNA itself has a long history of ties to Islamic extremism. As Jordan Schachtel of Conservative Review notes, Sarsour began the speech by thanking Siraj Wajjah – a man "listed as an unindicted co-conspirator in the 1993 World Trade Center bombings." It got worse from there. She ranted: *Why sisters and brothers, why are we so unprepared. Why are we so afraid of this administration and the potential chaos that they will ensue on our community?...I hope, that when we stand up to those who oppress our communities, that Allah accepts from us that as a form of jihad....We are struggling against tyrants and rulers not only abroad...but here in the United States of America where you have fascists and white supremacists and Islamophobes reining in the White House.*

She concluded, *"Our number one and top priority is to protect and defend our community. It is not to assimilate and to please any other people in authority. And our top priority...is to please Allah, and only Allah."* Sarsour, who was called a "Champion of Change" by the Obama White House, has a long history of speaking kindly of shariah law and terrorists. 

After graduating in 1906, Black worked as a lawyer in Ashland, Alabama where he specialized in labor and personal injury cases.

During the early 1920s, Black became a member of the Ku Klux Klan ("KKK"), a racial/religious based terrorist group predominantly located in the South. At the time Black joined, the KKK was a big part of the Birmingham labor movements

Supreme Court

Black was the first of nine justices to be nominated by President Roosevelt to the Supreme Court.

After his history of being involved in the KKK was revealed, many people called for the Senate to deny Black a seat on the Court. But, this petition failed and in 1937 Black was sworn in as a justice.

Black also wrote the majority opinion in the decision of Everson v. Board of Education.

In that case, a taxpayer brought suit claiming that indirect aid to parents of children in private religious schools by taxpayer money violated the First Amendment. The majority, in a 5-4 decision, decided that the aid was permissible because the indirect aid was provided to all students regardless of whether or not they attended religious schools. Also, since the payments were not made to a religious institution but rather given to the parents of students, the First Amendment's separation of church and state was not violated. *Everson v. Bd. of Educ.*, 330 U.S. 1 (1947).

Writing for the majority in *Engel v. Vitale*, Black articulated the Court's decision that government-written prayers should not be recited in public schools. The Court found that reciting such prayers in public school violated the Establishment Clause. *Engel v. Vitale*, 370 U.S. 421 (1962)

*Liberty Counsel Responds to SPLC*



*BURLINGTON, VT - Today, Liberty Counsel filed a comprehensive response in federal court to the lawsuit backed by the Southern Poverty Law Center (SPLC) in the case of Jenkins v. Miller, et al. The legal Memorandum of Law is 116 pages, not counting affidavits. Liberty Counsel also filed a second Motion and Memorandum of Law raising Vermont's anti-SLAPP, which prevents suits designed to restrict free speech. This false labeling has serious consequences.
