Donald Trump during a news conference in New Delhi on Tuesday. In Improper Payments Since 2004 Adam Andrzejewski Senior Contributor Since 2004, twenty large federal agencies admit paying out astonishing \$1.2 trillion in improper payments. That amounts to more than one-quarter of President Trump's proposed \$4.7 trillion budget for 2020. Last year, these improper payments totaled \$140 billion – that's about \$12 billion per month.

But what exactly is an improper payment? Federal law defines the term as “payments made by the government to the wrong person, in the wrong amount, or for the wrong reason.” In other words, there's a lack of basic in-house financial controls within the largest federal agencies. When people or companies receive money they don't deserve, it erodes our trust in government, our economy and government's ability to finance everything from defense to health care.

Improper payments in health care are especially troubling. In 2011, when President Barack Obama signed the Affordable Care Act, Congress vowed to help pay for it by rooting out waste, fraud, corruption and taxpayer abuse from the Medicare and Medicaid programs. The biggest offenders across government include: Human & Human Services (HHS); Internal Revenue Service (IRS); Social Security Administration (SSA); and the departments of Defense (DOD), Labor (DOL), and Education (ED). What were some of the ways these agencies wasted our tax dollars last year? Dead people received \$1 billion in benefits. Medicare, Medicaid,

social security payments and also the federal retirement annuity payouts (pensions) kept flowing to dead recipients.


- College students were overpaid by nearly \$6 billion in Pell Grants and student loans. Approximately four percent of all payments were improper, and ED forecasts a worse figure in FY2019.
- Social Security recipients were overpaid by \$10 billion. Six million active Social Security numbers belong to people aged 112 and older. Here's the problem: there are only 40 people in the entire world aged 112 and over.
- \$18.4 billion in Earned Income Tax Credit overpayments. Millions of low-income families who Congress designated as qualified recipients were overpaid billions of dollars. The program is rife with errors: the government overpaid \$1 in every \$4 to beneficiaries. (The IRS administers the program and responded to our request for comment here.)
- Medicare & Medicaid improperly paid \$85 billion in benefits with overpayments amounting to \$67 billion. Administered by HHS, Medicaid admits to overpaying recipients \$36 billion. Medicare admits to \$31 billion in overpayments.

The examples are endless.

The government paid doctors who were stripped of their medical license. Farmers were overpaid \$242 million on crop subsidies, insurance, direct payments, and loans.

Unemployment insurance recipients received \$3.6 billion in over payments administered by the states through the Department of Labor.*

The Pentagon overpaid \$1.2 billion for things like civilian, military, retirement and travel pay, health benefits, and more.

Here are 10 examples of what \$140 billion in improper federal payments could have purchased:

10 billion Netflix subscriptions (\$13 monthly)
 320 million fancy bicycles (\$425 each)
 140 million root canals (\$1,000 each)
 28 million teenagers getting braces (\$5,000 each)
 5 million hip replacements for seniors (\$32,000 each)
 700,000 additional doctors hired at VA (\$200,000 each)
 1x year of all Federal pension payouts (\$130 billion)

The lack of accounting control is so bad that the \$140 billion cost in bureaucratic mistakes exceeded the entire executive agency payroll. Despite this, 99.7 percent of the federal workforce is rated "highly successful," and more than one million bureaucrats received a performance bonus last year. The 1.3 million bureaucrats in the executive agencies earned \$120 billion last year according to our data at OpenTheBooks.com. Therefore, for every \$1 million in federal payroll, the agencies admitted to \$1.2 million in improper payments. So, aren't federal agencies working to recapture these improper payments? Not exactly. In fact, outside of overpaid contractors, the Office of Management and Budget says that recapture audits don't make financial sense. They argue that it costs too much to claw back the improper payments.

The American people need to raise our voice. It's time to crack down. Every dollar that goes toward an improper payment is a dollar taken from a taxpayer or diverted from a critical government function. Tell Congress and the Administration to put in place better safeguards to prevent this massive waste of national resources. Note: We requested comment from each agency mentioned in this piece. *The Department of Labor has been aggressively working with states to address unemployment insurance improper payments, providing intensive oversight and technical assistance to states with the highest improper payment rates and providing tools and resources to help all states better prevent, detect, and recover improper payments.

The Farm Workforce Modernization Act of 2019, H.R. 4916, introduced by Congresswoman Zoe Lofgren (CA-19), would grant amnesty - including work permits, green cards, and a path to citizenship - to illegal aliens who have been unlawfully employed in agriculture during the past two years. In fact, illegal aliens who spent just most weekends working in agriculture over two years would qualify, since only 1,035 hours or 180 workdays are required according to analysis shared with us by our friends at NumbersUSA.

The purpose of the bill, ostensibly, is to ensure a stable and legal agriculture workforce. Naturally, the first step would be to reform the H-2A guest worker program that allows employers to import an unlimited number of workers each year for temporary, seasonal agricultural work. The current H-2A program, while used successfully by many growers to obtain agricultural workers each year, is bureaucratic and cumbersome. But, no, unfortunately, that is not the primary focus of H.R. 4916. Rather than simply streamlining the H-2A program, Title I of the bill is all about amnesty. Congress knows that giving amnesty to illegal agricultural workers will fail to produce a stable, legal workforce because they've tried it before.

Under H.R. 4916, if an alien worked unlawfully in agriculture for at least 10 years prior to the date of enactment, that alien will be granted Certified Agricultural Worker (CAW) status for

5½ years with an employment authorization document that allows him or her to work for any employer in the United States, in agriculture or not. After four years in CAW status, the alien can apply for a green card and the path to citizenship, if the alien worked in agriculture for at least 575 hours or 100 workdays in each of those four years. So these longtime illegal workers are “only” indentured for four years. However, if an alien worked unlawfully in agriculture for fewer than ten years prior to enactment, that alien also will be granted CAW status but will be required to work in agriculture for the next eight years. Aliens in this category cannot apply for a green card and the path to citizenship until they have had CAW status for eight years and can show that they worked in agriculture for at least 575 hours or 100 workdays in each of the past eight years.

So these aliens who worked unlawfully for less time will be indentured to agriculture for eight years before they can completely abandon farm work. Like the first category, though, they will still have an employment authorization document that is not limited to agriculture. Rather than providing incentives for mechanization to reduce the need for manual labor, or even just streamlining the existing H-2A program, the sponsors of H.R. 4916 decided that it is time to complete the hollowing out of several other industries, in addition to seasonal farm work. Truthfully, it is ironic that the sponsors of this bill put the word “modernization” in the title since the legislation actually proposes variations on two tried and demonstrably failed policies of the past: amnesty and indentured servitude.

In addition, they, the same sponsors who support such an egregious process of indenturing aliens as they strive to become new immigrants, kept the numerically unlimited H-2A category for seasonal work but created a new, non-seasonal, year-round category so that at least 20,000 (and potentially many more) low-paid foreign workers can be imported each year to work at dairies, meat-packing plants,

fish canneries, nurseries, and more. But rest assured, after three years of this new program, the government will study H.R. 4916's impact on the wages and working conditions of the (by then) few remaining Americans and legal immigrants in these occupations! Finally, in what appears to be an effort to placate folks who remember the results of the 1986 IRCA amnesty, the sponsors of H.R. 4916 threw in mandatory use of E-Verify to ensure that new hires are authorized to work in the United States—but ONLY for agricultural employers! The bill includes no provisions to reduce the flow of illegal immigration into the United States, but it does ensure that they won't be employed in agriculture. Instead, they will be competing with Americans and legal immigrants for jobs with unscrupulous employers in other industries where E-Verify use is not required. Now that the Lofgren bill has passed the House our sources on Capitol Hill tell us that there is growing interest among some GOP Senators to pass this monstrosity. The latest information is that Sen. Thom Tillis (R-NC) and Senators Lindsey Graham (R-SC) and James Lankford (R-OK) are also on board. Tillis is expected to be the lead in introducing the Senate version. What's even more amazing and disheartening is that Vice President Pence's PAC organization is rumored to be prepared to spend \$30 million on an ad campaign to promote this despicable attack on American workers.

EVERY CHRISTIAN NEEDS TO READ THIS ABOUT BERNIE SANDERS FEBRUARY 22, 2020

Lord, seeing this news, we pray Your people will be stirred to get out and vote this November. The daughter of a radical Islamist operative is a state co-chair of presidential frontrunner Bernie Sanders' presidential campaign. Sanders named Abrar Omeish, daughter of Libyan-born jihadist sympathizer Esam Omeish, as a co-chair of his Virginia campaign on February 18. On her own merits, the 24 year-old Abrar Omeish is of little political consequence. She is the youngest person to ever hold office in the state, having been elected in 2019 to the Fairfax County School Board. Her role on the campaign appears to be a Sanders gesture to a more powerful political constituency: the well-organized radical Sunni Islamist networks across the United States. Abrar Omeish's father is former president of the Muslim American Society, a group identified by federal prosecutors as the "overt arm" of the U.S. Muslim Brotherhood.

Advancing what her father started

The younger Omeish appears to have followed in her father's footsteps, including in affiliating with Muslim Brotherhood groups. She has been noted for close ties to the International Institute of Islamic Thought (IIIT) an Islamist think tank once raided by federal law enforcement over ties to Hamas and Palestinian Islamic Jihad fundraising. Abrar served as president of the Muslim Brotherhood-founded Muslim Students Association while at Yale University, participating in an effort to deplatform Ayaan Hirsi Ali, an author and former Muslim who campaigns for women's rights.

Abrar Omeish is not the first Muslim leader with Islamist ties to serve as a surrogate for the Sanders campaign but is another example of the growing political alliance between Islamists and socialists.

Perhaps Sanders' most famous surrogate is New York-based Islamist activist Linda Sarsour, who was expelled from the Women's March following controversy over her antisemitism. Others include Reps. Ilhan Omar and Rashida Tlaib, both of whom have faced repeated controversies over antisemitic and inflammatory remarks and Islamist ties, have also endorsed Sanders. Sanders was also one of only two candidates to attend the annual convention of the Islamic Society of North America (ISNA), another Muslim Brotherhood-linked organization. In 2017, Sanders' surrogate Sarsour used the ISNA stage to call for a "jihad" against Donald Trump.

Well-organized cadre for voter mobilization

Sanders' Muslim outreach efforts may be

paying off. Muslim Brotherhood-affiliated organizations have run the most effective get-out-the-vote campaigns among ordinary Muslims in America for more than two decades, usually in concert with "progressive" Democrats and small but effective socialist organizing committees. In Iowa, where Sanders finished first, the Vermont Senator picked up significant numbers of delegates at Iowa mosques serving as satellite caucus locations.

One of Sanders' other Virginia co-chairs is the state's only openly Democratic Socialist, Delegate Lee Carter. While Virginia has a Muslim population of about 200,000 (roughly 2%), the population is most heavily concentrated in the Democratic strongholds of Northern Virginia where Sanders' Virginia co-chairs are located, including Fairfax, Loudon and Prince William counties, where the Muslim percentage of the population approaches 5%. While it is unclear how Muslim voters in Virginia will turnout, EmgageUSA, an Islamist political advocacy group with ties to Muslim Brotherhood affiliates, claims that Muslim voter turnout in Virginia reached nearly 70% in the 2016 general election. If true, Muslim voter turnout in Virginia was significantly better than Muslim voter turnout nationally, which Pew polls put at roughly 44%.

Whether Sanders' strategy will be effective or not remains to be seen. A Monmouth poll currently puts Sanders tied with former New York City Mayor Mike Bloomberg ahead of Virginia's March 3 Super Tuesday primary. But Sanders has certainly staked much on the belief that siding up to Islamist leaders will deliver Muslim voters, and victory.

PRAYER POINTS

God tells us to (1 Tim. 2:1-4), and it is important that we obey Him (John 14:15, Acts 5:32). Second, because God answers prayer (Matt. 21:22, John 14:13-14). Third, God honors prayer and turns His attention to those who pray. He takes note of people who pray and His ear remains open to them (2 Chron. 7:14). Fourth, prayer not only gives God a vehicle by which He can respond and answer prayers, but prayer also changes those who pray, for praying helps us to be God-conscious, and when we are God-conscious as individuals, our behavior is different than if we rarely think about God (Rom. 1:28).

When a country drifts away from God, God drifts away from that country. When God drifts away from the country, His blessings also leave. Founding Father Samuel Adams ("The Father of the American Revolution") fully understood this and reminded citizens: May every citizen in the army and in the country have a proper sense of the Deity upon his mind and an impression of that declaration recorded in the Bible: "Him that honoreth Me I will honor, but he that despiseth Me shall be lightly esteemed" (1 Sam. 2:30).

Numerous other Founding Fathers understood this truth and clearly expressed it. In fact, political leaders for generations embraced this belief. For this reason, President Abraham Lincoln reminded the nation in the midst of the Civil War: "[I]t is the duty of nations as well . . . to recognize the sublime truth announced in the Holy Scriptures and proven by all history that those nations only are blessed whose God is the Lord (Ps. 33:12). . . ."

But we have forgotten God. We have forgotten the gracious hand which preserved us in peace and multiplied and enriched and strengthened us, and we have vainly imagined in the deceitfulness of our hearts that all these blessings were produced by some superior wisdom and virtue of our own. Intoxicated with unbroken success, we have become too self-

sufficient to feel the necessity of redeeming and preserving grace—too proud to pray to the God that made us. There is much consequence when a nation turns from God. After all, Psalm 9:17 (KJV) warns, "The wicked shall be turned into hell, and all the nations that forget God." God expects individuals to remember and acknowledge Him, but He also expects nations to do the same.

Proverbs 3:5-6 reminds us that in all our ways (public as well as private) we are to acknowledge Him; Psalm 79:6 and Jeremiah 10:25 call for God's wrath upon all nations that do not call upon His name; and the warranty of 1 Samuel 2:30 that "those who honor Me I will honor, and those who despise Me will be disdained" was delivered to the nation's civil leaders, not religious ones.
